LACERA Board Strengthens Role of Retiree Alternate Rep

Dear Friends,

Strong Voice for Retirees:

I'm very pleased to inform you that on April 13, 2006, the LACERA Board of Retirement voted to amend their By-Laws to allow the Alternate Retired Member the same opportunities and privileges consistent with those of the Alternate Safety Member. Prior to the By-Law amendment the Alternate Retired Member was:

- Not allowed to participate in discussions or make motions at Board meetings or serve on Standing or Ad Hoc Board Committees.
- Not allowed to hold a Board Office (Chair, Vice Chair, and Secretary.)
- Not allowed to sit in a Board Chair, and restricted to sitting in the audience.

The amendment cleared the way for the Alternate Retired member to sit in a Board Seat, take part in discussions, serve on Standing and Ad Hoc Committees and hold a Board Office such as Chair, Vice Chair, and Secretary. In accordance with the California County Employees Retirement Law of 1937, the Alternate Retired Member can only vote when the Regular Retired Board Member is absent.

This By-Law amendment change is a big victory for RELAC and all County Retirees. This is a first because it gives retirees an additional voice at the LACERA Board of Retirement meetings. As you know, **Edward C. Morris** your current RELAC President, is your elected Alternate Board Member. Ed's proven commitment and dedication to retirees, along with his knowledge and administrative skills, will benefit the Retirement Board and all active and retired County employees. I would like to acknowledge and thank the members of the LACERA Retirement Board for making this progressive amendment change.

Co - Pay Increase in Caremark Mail Order Prescription Drug Plan:

By the time you read this article, LACERA retirees enrolled in Blue Cross Plans I, II and III should already be aware of the co-pay increase in the Caremark Mail Order Prescription Drug Plan, effective July 1, 2006 as follows:

Caremark Mail Order Drug Prescription - 90 day supply

2005-2006 Co-Pays

\$ 7 co-pay for generic
\$15 co-pay for brand-name
N/A

\$15 co-pay for specialty drugs

2006-2007 Co-Pays

\$10 co-pay for generic
\$30 co-pay for preferred brand-name
\$50 co-pay for non-preferred brand-name
\$150 co-pay

The Convention itself was highlighted by the appearance of various politicians from the California State Assembly and Senate and other elected State officials. i.e., Lt. Governor Cruz Bustamante, Attorney General Bill Lockyer, Insurance Commissioner John Garamendi, State Treasurer Phil Angelides, State Controller Steve Westly and the State Superintendent of Public Instruction Jack O'Connell, all of whom spoke of the State's various problems according to their individual area of responsibilities.

The Congress of California Seniors is a non-political organization and makes no endorsements for political candidates.

After all the welcomes the Convention then broke into 4 individual workshop meetings; namely:

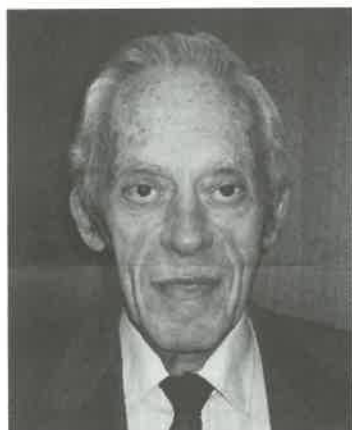

RELAC Board Member Fingold Elected to State Senior Legislature

Sol Fingold, a member of the RELAC Board of Directors, has been elected to the position of Assembly member in the California Senior Legislature. The senior legislature was established by state law and meets for four days in October of every year in the State Capitol. Its purpose is to develop legislative proposals related to the interests of seniors and to present them to the state legislature and to the United States Congress.

Members of the legislature are elected to two year terms. The voting takes place at Senior Centers throughout the state and all Californians who are 60 or older are eligible to vote. Eighty persons are elected to the Senior Assembly and 40 to the Senior Senate.

The legislators address issues related to health, insurance, housing, transportation and social and community services. In recent years the state legislature has passed and the governor has signed into law bills based on Senior Legislature proposals which strengthen protections

against elder abuse, improve regulation of skilled nursing facilities, and extend the rights of residents of mobile home parks.

The senior legislature is not funded by taxes but by voluntary contributions.

We can be sure that as a senior legislator, Sol will pursue the interests of RELAC members. He will report on the legislature's activities after its October session. If any of our readers have concerns that may be addressed by state or federal legislation they may send a letter or e-mail to Sol Fingold in care of the RELAC office.

V. Frances Jaffray Was Generous Donor to RELAC

RELAC member V. Frances Jaffray passed away on April 27, 2006. She was approaching her 102nd birthday.

We especially note Ms. Jaffray's death because for many years she voluntarily donated \$10 a month to RELAC. We do not know what her contributions added up to over the years, but no doubt the amount was large. It was very much appreciated.

Ms. Jaffray worked for the County Clerk, subsequently lived in Tucson, Arizona and joined RELAC in 1963.

While the \$150 co-pay for specialty drugs may seem very high, you should know and realize that the average cost of specialty drugs used by LACERA members is \$2,500 for a three month supply. Specialty drugs or non-preferred brand names are used for uncommon ailments such as organ transplant therapy and certain type of cancers. The co-pay increases were necessary as prescription drug costs have increased to an average of \$62 for generic and \$245.00 for name brands for a three month supply. LACERA management and our Mercer Medical Consultants advised the LACERA Retirement Board Members that the increases were necessary in order to keep our Mail Order Drug Plan as we know it.

I am the current Vice President of CRCEA (California Retired County Employees Association). I am continually checking what other Counties throughout California are doing with their retiree health plans. I can state without hesitation that Los Angeles County Retirees have the best Medical Plans (including prescription drugs) of any County in California. We should be very thankful to the County of Los Angeles, who pays for our Medical Plans and LACERA for doing an outstanding job in administering the Plans.

I strongly urge you to read the annual Medical Plan Information (large envelope) that was recently mailed to you by LACERA. It provides an update on all of the plans offered including Dental and Vision. Save it, it's a good reference guide. If you have any questions regarding your Medical Plan, please contact the LACERA Insurance Services at (800).786-6464 or (626) 564-6132.
