# Retirement Board by Bill de la Garza Your Elected Retirement Board Trustee



Dear Friends,

From all indications, it looks like 2008 will be a very challenging year for public employee retirees. Newspaper articles and some illinformed publicity seeking politicians continue to take cheap shots at public sector retirees by indicating that our "extravagant and lavish pension and medical plans" will initiate local and state government bankruptcies and dip into the budgets of public services such as schools, fire and police protections, street and highways, parks and recreation, libraries, etc. I really don't know where they get their facts or figures. Did you know that the average LACERA general member retiree receives a monthly benefit of \$2,470? The average safety member receives \$4,730. Many of these retirees do not receive a social security benefit. I consider these moderate benefits which keep us off the welfare rolls, but they should not be considered extravagant or lavish. Did you know that 80 to 85% of our pensions are paid for by the earnings of LACERA'S investments? No one ever talks about the monthly deductions that were taken from our salaries from the start to the ending of our careers. Yes, we do have a good pension plan that is well administered. We worked hard and paid for this promised plan.

#### Public Employee Post-Employment Benefits Commission Good and Bad News

For the past year we have attempted to keep you informed on the Governor's PEPEB Commission. The 12 member commission was formed by Governor Schwarzenegger for the purpose of addressing public pension and retiree health care funding issues across the state of California. The commissions report was published on January 8, 2008. The final report was over 325 pages long including a 14 page executive summary. The results of the report initiated numerous newspaper articles throughout the state of California. I believe that the report had some bad news and some good news. As I expected, there were not any major surprises. The majority of the recommendations in the report centered on the necessity of "pre funding" retiree medical plans for the purpose of reducing unfunded liability which has been caused by triple digit inflation in health care costs.

The bad news of the report is that it stimulated newspapers to print that "local governments are facing an unfunded liability of \$118 billion or more over the next 30 years in order to fund the promise of generous healthcare benefits for retired public employees. An article in the <u>Daily News</u> stated that Los Angeles County's costs for retiree health care have nearly tripled in the past decade, soaring from \$100 million in 1997-98 to about \$366 million this year. The good news is the Governor Schwarzenegger said in a statement, "Lowering health and pension benefits paid to employees who are already retired is illegal, according to pension experts, while modifications to benefits offered to current employees require agreement from unions during the collective-bargaining process." The Governor also stated "California governments must keep their promises to the hardworking men and women who have served the public, without

At the January 9, 2008 meeting of the LACERA Board of Investments, the first order of business was to elect its officers for the year. Congratulations to the following Board Members:

I enjoyed visiting with those of you who attended RELAC's Annual Installation Luncheon and joined in celebrating RELAC's 50<sup>th</sup> Anniversary. RELAC will continue celebrating throughout the year and I look forward to seeing you at future events.

Given the recent news about the sub-prime lending mortgages and the impact it has had on the market, I felt compelled to remind you once again that LACERA is a long-term investor and that LACERA has its portfolio invested over a variety of asset classes, namely, equities, bonds, real estate and private equity. Each asset class is then diversified to minimize investment risk. For example, real estate investments are diversified by geographic region, property type, and investment manager.

At the risk of sounding like a broken record allow me to remind you that our pensions are guaranteed for life. I for one will continue to sleep at night knowing that our pension fund is in good hands and is prudently invested.

#### THIS IS FOR THE ACCOUNTANTS

The LACERA Annual Financial Statements for the Fiscal Years ending June 30, 2007 and 2006 as audited by LACERA's external auditors, Brown Armstrong, CPAs, confirms that LACERA had two more good years and remains financially sound.

Listed below are the financial highlights (comparing fiscal year 2007 to 2006) as reported by Ms. Beulah Canevari, Manager of the Financial and Accounting Services Division.

- Net Assets Held in Trust for Pension Benefits, as reported in the Statement of Net Assets, total \$40.9 billion, an increase of \$5.72 billion or 16.3 % from last year.
- Total Additions as reflected in the Statement of Changes in Pension Plan Net Assets are \$7.59 billion primarily as a result of Investment Income and Net Appreciation in the Fair Value of Investments. This represents an increase from the prior year of \$2.52 billion or a change of 49.8%.
- Total Deductions as reflected in the Statement of Changes in Pension Plan Net Assets total \$1.84 billion, a decrease of \$4 million or 0.2% from prior year.

- The latest actuarial valuation completed by Milliman, Inc., LACERA's independent actuary, was as of June 30, 2006 and determined the funding status (the ratio of system assets to system liabilities) to be 90.5%.
- On average over the past ten years, investment returns make up approximately 80% of the annual additions to the fund.
- For the fiscal year ending June 30 2007, LACERA's total fund on an annualized basis returned 19.1% gross of fees, and 18.8% net of fees.



# BECOME AN ADVOCATE FOR AN ABUSED CHILD IN FOSTER CARE

CASA of Los Angeles is currently recruiting Court Appointed Special Advocate (CASA) volunteers. Trained volunteers investigate the circumstances of children who have been removed from their homes due to abuse or neglect and placed in protective custody. CASAs advocate for the best interest of foster children both in court and in the community. Volunteers must be minimum 21 years old, be able to make at least a 2 year commitment to the program, undergo a background check, and successfully complete a 36-hour CASA training. An average of 5 hours per week is spent on case activities. Bilingual (Spanish/ English) and African American volunteers are especially needed. The application process for the CASA Volunteer Training is underway. We offer five trainings annually. Ensure your spot! Volunteers must attend an Orientation session before the training. 




