McCauley must obtain 433,971 qualified signatures by November 8, 2010. If this initiative does qualify for the ballot, rest assured that RELAC will join in the battle to defeat it.

#### Investments Board

In spite of the continued economic uncertainty and volatility in the financial markets, the LACERA portfolio is holding its own. According to the latest report from Lisa Mazzocco, LACERA Chief Investment Officer, the estimated market value of the total fund



as of August 31, 2010 is \$34.1 billion. The market value of the total fund increased when compared to the market value as of June 30, 2010 which was \$33.3 billion. Please note the real estate and private market values are calculated quarterly. Consequently, the market values for months that are not quarter end reflect the most recent quarter end data.

The breakdown of the portfolio as of August 31, 2010 is shown below.

#### News From LACERA

#### VIA PHONE OR COMPUTER, LACERA HAS WAYS TO HELP YOU.



Save time and the cost of a stamp – call LACE-RA to request forms or to update your personal information.

Occasionally I'll review our correspondence queues to see what types of issues or questions members are inquiring about. I've noticed a number of times where retirees have written in to request that we mail them a form or brochure.

While we are happy to fulfill any requests, I want to share helpful alternatives that, as a retiree, you could consider the next time you need information from LACERA. Did you know that presently it costs 44 cents to mail a letter (I hate to date myself, but I remember when it cost 5 cents!). There's also the time factor to consider because it takes a few days for your letter to arrive at LACERA offices where we scan it into a work queue. Written requests for information or forms are processed by staff on a first-in, first-out basis. Then you have to wait a few days for the material to arrive in the mail.

#### www.lacera.com

Most of our written material is available on www.lacera.com on the Brochures & Forms page to view or download; or members can place an order from the website to receive them via mail.

#### 1-800-786-6464

We understand that some of our retirees don't use the Internet, so another option is to call our toll-free number (1-800-786-6464) with your request.

When you call, the first step is to answer a few questions to validate your identity. Once this is complete, our staff can safely change your address, beneficiary information, direct deposit information, etc. An additional benefit to calling LACERA is that our Retirement Benefit Specialists in the Call Center may be able to assist you with your request right over the phone, eliminating the need to mail a form to you. If you call, we can put the material in the mail the same day.

LACERA offers a variety of ways for retirees to get in contact with us. These methods reflect



The California Foundation for Fiscal Responsibility (CFFR) describes itself on its website as an organization "committed to educating the public and key decision makers about California public employee retirement benefit issues and developing fiscally responsible solutions that are fair to employees, employers and taxpayers."

CFFR served LACERA with a request under the California Public Records Act seeking disclosure of the names or all retirees whose monthly benefit exceeded \$8,333 in any month during calendar year 2010. (A monthly benefit of \$8,333 equates to an annual benefit of \$99,996.) CFFR publishes on its website a searchable data base that enables members of the public to ascertain the pension received by any CalPERS or CalSTRS retiree that equals or exceeds \$100,000 per year. CFFR refers to its lists as "The CalPERS \$100,000 Pension Club" and "The CalSTRS \$100,000 Pension Club."

On July 8, 2010, LACERA denied CFFR's request for names, but indicated LACERA would provide general LACERA payroll information, including retirement allowance payments of more than \$8,333 per month, without regard to individual members or their names, should CFFR wish to amend its request.

LACERA's denial was based on two principles:

- 1. A provision in the County Retirement Law specifically says that "individual [retirement] records of members shall be confidential."
- 2. The Public Records Act authorizes the government to withhold disclosure when the government's interest in keeping the records confidential clearly outweighs the public's interest in disclosure. LACERA advised CFFR: "Given that the records you seek provide a window into intimate financial decisions of our members without giving the public any insight into whether the amounts being paid are correct; and, given that the release of this information may have a chilling effect upon the financial decisions our members make, we believe the public interest in non-disclosure outweighs the public interest in disclosure."

LACERA advised CFFR of the many factors that determine a retirement allowance, like the member's purchase of public service credit or additional retirement credit (ARC), or the retirement option selected by the member (unmodified, unmodified plus, Option 1, Option 2, etc.). Thus, disclosing pension amounts "reveals very little about what has been contributed by the public employer toward the benefit received."

As of this writing, CFFR has neither amended its Public Records Act request nor commenced litigation. This may be because there is already a lawsuit pending that is expected to resolve whether county retirement systems, including LACERA, can continue keeping an individual's retirement allowance confidential. The lawsuit was filed by the Sacramento Bee and the First Amendment Coalition (a special interest group representing media interests) after the Sacramento County retirement system refused to disclose the names and amounts of individual retirees. On July 13, 2010, the Superior Court in Sacramento ordered the retirement system to disclose the requested information and the retirement system has appealed that order to the Court of Appeal in Sacramento. The briefs are due to be

completed by mid-December 2010, and oral argument will be held after the court has had a chance to review them.

Four county retirement systems, Orange, San Bernardino, Sonoma, and Tulare, have filed papers with the Court of Appeal supporting the right to keep retirement allowances confidential. LACERA is expected to file it's supporting brief sometime in October 2010. In addition, the Sacramento County Retired Employees Association (SCREA) has filed a supporting brief that makes the following cogent argument:

"Many of SCREA's members are deeply distressed that their individual records may be disclosed at the request of any party regardless of their motivation for making this request. This is of particular concern to SCREA because of it efforts to educate its membership about the importance of guarding their personal financial information in order to protect themselves from such things as identify theft, and from becoming a victim of various con schemes. A recent article that appeared in our newsletter, "News Briefs", June 2010 edition, is an example of such efforts. The very fact that their names and monthly retirement income could be made public, even published, exposes its members unnecessarily to potential financial abuse or fraudulent schemes."

CFFR and the Howard Jarvis Taxpayers Association have joined in an opposing brief in which they argue, among other things, that the law making records confidential only applies to records filed with the retirement system by the member, and if disclosure is not allowed, "[t]he public would be harmed because pension fraud embezzles public funds, but would go undetected if pension records were concealed from public view."

Aruling from the Court of Appeal in Sacramento is not expected until late spring or summer 2010. It should be noted that if the Court does find that retirement amounts are subject to public inspection, all retirement amounts will become subject to public disclosure, not just those over \$8,333 per month.


