You are eligible to join RELAC if you are:

- A retired employee of Los Angeles County or a special district of the County who receives a retirement allowance from LACERA;
- A surviving spouse or partner, or
- An active employee of Los Angeles County or a special district that participates in LACERA who is within five years of retirement.

What does it cost?

- \$2.50 per month for retired members, paid through a monthly deduction from LACERA to RELAC or annually (\$30.00) paid by check to RELAC.
- \$30.00 per year for active members, paid by check to RELAC.
- \$1.00 per month for retiree spouses/partners paid through a monthly payroll deduction from LACERA to RELAC or annually (\$12.00) paid by check to RELAC.

ABOUT RELAC

RELAC is a non-profit organization composed of both active and retired employees of Los Angeles County, and special districts participating in LACERA. Founded in 1958, RELAC's most important role is to advocate on behalf of Los Angeles County retirees to protect their pension and medical benefits and is the only Los Angeles County organization dedicated exclusively to that goal.

The retiree seats on the LACERA Boards of Retirement and Investments have historically been filled by Directors of RELAC, helping to ensure that retirees' interests are protected. RELAC also works closely with the Los Angeles County Board of Supervisors, the Los Angeles County Management Council, and the California Retired County Employees Association (CRCEA), an organization representing over 150,000 state-wide county retirees.

OUR MISSION

To ensure the pension and health care benefits earned by Los Angeles County employees are protected while promoting their health, well-being, happiness and continued productivity.



MEMBERSHIP BENEFITS

Advocacy. We stand ready to defend the hard-earned pension and health care benefits of Los Angeles County retirees against efforts to take away or diminish them in any way.

Representation. In addition to historically occupying all three retiree seats on the LACERA Boards of Retirement and Investments, RELAC participates in the statewide California Retired County Employees Association (CRCEA) as its largest organizational member. Your interests regarding pension and health care issues are protected through these relationships.

Staying Connected. Every other month, RELAC publishes a newsletter to keep our members informed and connected with current information regarding retiree benefits, planned events and announcements of interest. Our website, www.relac.org, provides additional information.

Social/Recreational Programs. We hold various General Membership and regional meetings throughout Los Angeles and neighboring counties to provide important retiree information. RELAC sponsors an annual recognition luncheon, several golf tournaments throughout the year for men and women, RV outings, and a popular annual picnic in the fall. In addition, RELAC sponsors a "Night at Dodger Stadium" for July 4th and a "Day at the Races" at Santa Anita Racetrack. Members also have access to the TicketsatWork discount ticket/service program.

Supplemental Benefits Programs. RELAC offers its members supplemental benefits in the form of competitively priced group-discounted insurance products, such as dental, pet, vision, travel, identity theft, hearing aid, car, and home.

Community Involvement. We support and participate in the March for Babies Walk, help those with food insecurity by partnering with the L.A. Regional Food Bank, and support the Fire Department's Spark of Love toy drive. RELAC's annual scholarship award program provides RELAC members and their families with five \$1,000 scholarships as an investment in future generations.

YOUR PENSION AND HEALTH CARE WATCHDOG

We proudly work to protect the following benefits you have earned:

- **Retiree Pension Benefits:** a Defined Benefit (DB) Plan which pays retirees a lifetime monthly allowance and has spousal survivor's benefits.
- **Retiree Health Care Benefits:** Pays for health care coverage up to approved maximums.
- **Death Benefit:** Pays \$5,000 to the beneficiaries upon the death of the retiree.
